On behalf of the **Executive Committee 2014-15** and my personal behalf, I wish you and your near and dear ones a **Great Year Ahead**. Here's to a **New Year** of goodness, peace, health, songs, music, family, friends, books and everything in between...

Dear Members, this is to inform you that a **Special General Meeting** was held at '**Utsarga**', our Community Building, on **21.12.2014** to review the donation amount and other related charges for using '**Utsarga**', for our Donor Members as well as non-members and outsiders for social or other occasions.

The following are the decisions.

➤ **DONATION FOR USING OUR COMMUNITY BUILDING FOR FULL-DAY USE**

- **Rs 20,000 per day** for Non-Members and Outsiders of our Block.
- **Rs 10,000 per day** extra will be charged if air-conditioners are used.
- **Rs 5,000** (refundable) security deposit will also be levied.

➤ The Special General Meeting also decided that there will be no provision of **Half-Day Use**.

➤ It is to be noted that the **Special General Meeting** empowered the President and the Secretary to make a final decision on the electricity and other allied charges for the use of air-conditioners for our Donor Members, and also the

donation amount for the use of '**Utsarga**' for the '**Shraddha Ritual**' of our Members.

- I would like to inform you that it has been decided that the Donor Members will charged **Rs 4,000** extra per day for the use of air-conditioners. The donation amount for the use of '**Utsarga**' for Donor Members remains unchanged at **Rs 5,000 per day**.
- As to the '**Shraddha Ritual**' of our Members, only a sum of **Rs 1,000 per day** will be levied as incidental charges such as garbage removal and water. There will no extra charges for using the air-conditioners.
- I would also like to inform the Members and Residents of our Block that due to unavoidable circumstances, the **Annual Sports** of the Block has been postponed from **4 January 2015** to **11 January 2015**, while the **Senior Citizens' Get-Together** has been rescheduled from **1 February 2015** to **15 February 2015**. I sincerely regret the inconvenience, if any. Thanks for your cooperation.
- I would also like to once again urge our Members and Residents to join the **Annual Get-Together** on **10 January 2015**, the notice for which was circulated earlier.
