It is a matter of great pride and delight that the new Executive Committee and the Office-Bearers were elected at the 38th Annual General Meeting held on 25 June (Sunday) 2017 (List of the Office Bearers and the Members of the Executive Committee of 2017-18 is attached).

As you already know that the number of Nomination Forms Submitted against each post for the Election of the office bearers and the members of the Executive Committee for the year 2017-18 remain the same as the number of vacant posts for election, all 21 candidates who have submitted their nomination for different posts elected unopposed.

In this context I also like to thank the Executive Committee 2016-17 not only for doing a wonderful job last year but also for ensuring that the entire process of election happens with a degree of absolute clarity and fairness.

Please also join me in thanking Mr Alok Kumar Pal and Mr Ajoy Kumar Maity, the two gentlemen, who constituted the Two Members Election Panel for Election of the Office Bearers and the Members of the Executive Committee of 2017-18. They deserve special appreciations from all of us for doing the job with utmost sincerity and efficiency.

At the outset, I, on behalf of the Executive Committee 2017-18 extend heartfelt gratitude to our Association Members for electing them through a transparent and democratic process.

I, on behalf of the Executive Committee 2017-18, would like to inform you of the following resolution, unanimously taken at the Annual General Meeting held on 25 June 2017.

- A K Saha and Company will audit all the accounts of our Block Association, including Durga Puja and Shyama Puja, Saraswati Puja and Block Library for the financial year 2017-18. **The remuneration has been fixed for the entire year Rs. 5,000/-.**
- **The daily wages of the Night Guards has been raised from present Rs. 100/- to Rs. 120/- with effect from 1st July 2017.** Also the **number of Night Guards has been raised from present four persons to six persons** to protect our residents better.
- **Uses of our Community building 'Utsarga' for various occasions for Non-residents and Non-donor members has been raised from earlier 20,000/- per day to 25,000/- per day with effect from 1st July 2017.** All other charges shall remain the same for all users of our Community Building 'Utsarga'.

I would also like to inform you that the Executive Committee 2017-18 at its first meeting held on 7 July 2017 made the following key decisions:

- **CO-OPTION:** As per the provisions of the Memorandum of the Block Association, the Executive Committee 2017-18 unanimously co-opted **Mr Debarpita Mitra of BA-5/1** as the **Assistant Secretary**, **Prof. Bhajan Sen of BA-4/2** and **Mr Radha Madhav Paul of BA-180** as **Members of the Executive Committee 2017-18.**
