Dear Members & Residents,

Date: 7th September 2026

I am pleased to announce that the Executive Committee for the year 2026–2027 was formed during the Annual General Meeting held on 30th August 2026.

- **Election of Office-Bearers and Executive Committee (2026–2027):** The election of the Office-Bearers and Executive Committee members for the 2026-2027 term followed the standard procedure established over the past 12 years, aligning with the country's democratic practices at all levels. The independent two-member Poll Panel received 21 nomination forms: **President: 1; Vice-Presidents: 2; Secretary: 1; Joint Secretary: 1; Assistant Secretary: 1; Treasurer: 1; Members: 14**

Since no nominations were withdrawn, all 21 candidates were elected unopposed. At the Annual General Meeting (AGM) held on August 30, 2026, Poll Panel member Mr. Shibaji Bose announced the names of the elected members including the entire poll process, and the attending Members at the AGM formally approved the new Executive Committee for the year 2026-2027

- **Appointment of Auditor:** The attending Members at the AGM reappointed A.K. Saha & Co. as the Association's Auditor for the 2026-2027 FY under the same terms and conditions as accepted in the previous AGM.
- Subsequently, during the Executive Committee's first meeting on **6th September 2026**, an additional Assistant Secretary and two committee members were co-opted (please refer to **Annexure A**).
- At the same meeting, the Executive Committee also constituted a **Special Sub-Committee for Durga Puja and Shyama Puja 2026**. The all-women leadership team for this sub-committee is as follows:
 - **Chairperson: Mrs. Kalpita Saha (BA 68);**
 - **Principal Conveners: Mrs. Jayeeta Paul (BA 180), Mrs. Pritha Sarkar (BA 185), and**

This Special Sub-Committee will convene a meeting shortly to form the full-fledged organising committee for both festivals, fix budgets and other relevant details such as subscriptions, etc.

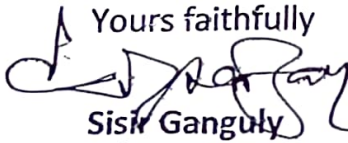

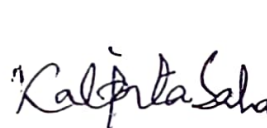
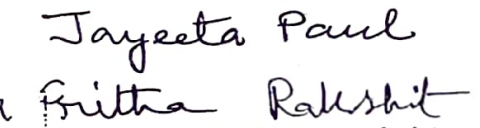
